

#### **EMPLOYMENT AND INCOME IMPACTS**

Forest-related economic activity in Amite County during 2013 generated 924 jobs and over \$39 million in income. That's about 16.9% of jobs and 27.1% of income in the county. Employment is the number of full- and part-time jobs in all sectors of the economy. Income is salaries and wages paid to employees.

#### TOTAL OUTPUT AND VALUE ADDED IMPACTS

Forestry and the forest products industry generated more than \$116 million, or about 20.9% of economic output, in Amite County. Forest-related value added amounted to over \$50 million, or about 20.1% of all value added in the county. The value of all goods and services produced is defined as total output. Value added is a portion of total output and represents the creation of new wealth.

#### **TAX IMPACTS**

Forest-related economic activity contributed an estimated \$13 million in tax revenue for federal, state, and local governments. This total includes tax revenue of \$8.7 million for federal and \$4.3 million for state and local governments.
